The regular meeting of the Henagar City Council was called to order @ 5:00 pm by Mayor Davis. **Roll Call**: Ms. Shankles, Mr. Callaham, Mayor Davis, and Mr. Trotman were present. Mr. Busby and Mr. McCurdy were absent.

**Reading of Minutes:** A motion to accept the minutes from the March 9<sup>th</sup> and April 13<sup>th</sup> meetings as written was made by Mr. Callaham. 2nd by Ms. Shankles.

- 1) Fire Department—Jeff Crump: Back-up lights have been installed on the Fire Department Tahoe. The Fire Hall needs an air compressor, which will cost about \$1,000. This will be purchased through the General account.
